**ORDER**

WHEREAS, Bihpuria PG Training, Ward No. 1, Bihpuria Town, Bihpuria, Lakhimpur, Assam-784161 (AS-S/N-2/2000) was granted recognition for B.Ed. course with an intake of 60 from the academic session 2001-2002 vide ERC order dated 23.05.2001, followed by revised recognition order issued on 25.05.2015 with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. AND WHEREAS, the ERC in its 272<sup>nd</sup> meeting held on 30<sup>th</sup> - 31<sup>st</sup> May & 1<sup>st</sup> June, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(I) vide order no. 60828 dated 19.06.2019 from the academic session 2020-2021 to the institution.

3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 19.06.2019. The Appellate Authority vide order No.89-320/E-130176/2019 Appeal/29<sup>th</sup> Mtg.-2019/11<sup>th</sup> October, 2019/83361 dated 25/10/2019 remanded back to the ERC with a direction to consider the documents given in appeal, to be submitted to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC, the documents submitted in appeal, with originals thereof, wherever necessary within 15 days of receipt of orders on the appeal.

4. AND WHEREAS, the ERC in its 277<sup>th</sup> meeting held on 19<sup>th</sup> - 20<sup>th</sup> December, 2019 considered the matter and as decided, Show Cause Notice was issued on 26.12.2019 to the institution on the following grounds:

- (i) No faculty from Perspective discipline appointed as per clause 5.2 B. of Appendix-4 of NCTE Regulations, 2014.
- (ii) Original FDRs has not submitted.

5. AND WHEREAS, the institution submitted reply vide letter dated 01.02.2020 received in this office on 10.02.2020. The ERC in its 280<sup>th</sup> meeting held on 29<sup>th</sup> February & 1<sup>st</sup> March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and decided as under:-


"Restoration of recognition order of B.Ed. course to be issued".


